Establishment of JV Company for the Production & Sales of Iso-nonyl Alcohol in Taiwan The Largest Investment Ever Held from Japan to Taiwan in the Petrochemical Area

We are pleased to inform that KH Neochem Co., Ltd. (hereinafter KHNC, the address of HQs : Chuo-ku, Tokyo, CEO & President : Keiichi Asai) signed the Joint Venture Agreement on Feb. 11th, 2015, among CPC Corporation, Taiwan (hereinafter CPC, the address of HQs : Sinyi District, Taipei, Chairperson : Sheng-Chung Lin) and Mega International Commercial Bank Co., Ltd. (hereinafter MICB, the address of HQs : Zhongshan District, Taipei, Chairperson : Y. T. Tsai) for the purpose of establishing the JV company to produce and sell Iso-nonyl Alcohol (INA).

INA is a higher alcohol and one of our company's major products which is mainly used for the plasticizer, Di-isononyl Phthalate (DINP). The demand of DINP has been increased rapidly all over the world for mainly auto-motive, electric wire & cable, and construction material.

KH Neochem Co., Ltd. has own technologies and know-how for INA production, and in order to meet the increasing demand of INA, KH Neochem Co., Ltd. has evaluated various options to establish a new production facility at a location with competitive feedstock and adequate volume for economic scale of INA production, as well as at favorable place for the access to the growing Asian market, such as China and India. On the other hand, CPC Corporation, Taiwan has been seeking to develop value-added downstream business diversifying from the traditional gasoline & fuel business, and had interested in INA business including the supply of their feedstock.

The two companies had conducted the feasibility studies and the negotiation of the commercial terms, after obtaining an approval of the project by Executive Yuan and a budget by Legislative Yuan in Taiwan. In the end, we reached the final agreement and signed the JV Agreement. This project is the largest joint investment venture ever held by Japanese and Taiwanese companies in the petrochemical area in Taiwan.
